COMPETITION RULES**

VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE 18 OR OLDER AT THE TIME OF ENTRY.

1) ELIGIBILITY:

Night in a Cave (the “**Competition**”) is open only to legal residents of France, United Kingdom, Germany, Spain, Belgium and The Netherlands who are at least 18 years old at the time of Entry. Employees, officers, and directors of Sponsor and its affiliated companies, subsidiaries, licensees, franchisees, distributors, dealers, sales representatives, advertising and promotion agencies, and any and all other companies associated with the Competition (collectively, the “**Competition Entities**”), and each of their immediate families (i.e., parents, spouse, siblings, children, grandparents, step parents, stepchildren and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to participate. 3) HOW TO ENTER:

No other methods of Entry will be accepted.

Entry in the Competition does not constitute Entry into any other promotion, competition.

In the event of a dispute regarding who submitted an Entry, the Entry will be deemed submitted by the holder of the Twitter account. “Authorized account holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4) WINNER SELECTION:

Sponsor will select 1 (one) Winner among all Entries meeting the Competition requirements:

- 1) Originality: Most original of all qualified Entries
- 2) Fun: Funniest of all qualified Entries
- 3) Creativity: Most creative of all qualified Entries.

In addition Sponsor will select 2 (two) alternate Winners. Prize will be reallocated whether i) not claimed or refused by initial Winner or ii) allocated first hand to a Winner disqualified or banned pursuant to Competition Rules or iii) due to a Force Majeure case.

5) WINNER NOTIFICATION:

It is the Winner's responsibility that his/her account is configured to allow private messages. 6) PRIZE:

3 days & 2 nights package exploring a cave located in the Pyrénées area (Ouzous) in France for the Winner and the at least 18 years old travelling companion of his choice.

Accommodation, transportation, catering and travels costs will be borne by the Sponsor.

Day 1 – Sunday January 30th 2016: travel from the airport nearby residency place to Lourdes-Tarbes Airport, France

Night 1- Sunday January 30th 2016: stay in an hotel in Lourdes city

Day 2 – Monday February 1st 2016: transportation by car to the cave and survival training (discovery of techniques and methods in the wildlife)

Night 2 - Monday February 1st 2016: night in the cave

Day 3 - Tuesday February 2nd 2016: travel back (transportation from the cave to the airport/train station + flight/train)

Minimum Estimated Retail value for 2 persons (“ERV”): 2 800€ (two thousand and eight hundred euros)

- Transportation (Plane/ Train + Transfer): 1350€ (one thousand and three hundred fifty euros).

Plane / Train round trip: Approximate price at 600€ per person for a total of 1200€ (One thousand and two hundred euros) for two persons.

Transfer: From the Lourdes-Tarbes Airport/or a nearby train station to the hotel, from the hotel to the cave and from the cave to the airport/train station for a total of 150€ (one hundred and fifty euros) for two persons.

- Hotel: 1 night stay in a standard hotel in Lourdes city for a total of 300€ (three hundred euros) in case of separate rooms and 150€ (one hundred and fifty euros) in case of a single room.

- Meal: Ubisoft will offer participants 1 full meal on the day of arrival, 3 full meal on the day of activities, 1 full meal on the day of departure. Cost of the meal will be 25€ (twenty five euros) maximum per meal for a total of 250€ (two hundred fifty euros) for two persons.

The choice of flight, hotel and restaurant accommodations composing this Prize shall be decided by Sponsor at Sponsor's sole discretion.

Ground transportation may be provided to the Winner and/or travelling companion in lieu of air transportation if the Winner and/or travelling companion lives within a 300 kilometers radius of the arrival airport.
