

THE TOM CLANCY'S RAINBOW SIX® SIEGE GAMES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Tom Clancy's Rainbow Six® Siege Games (the "Promotion") will consist of five (5) live activations ("Events") that will run between July 9, 2015 at 12:00:00 AM Pacific Standard Time ("PST") to October 1, 2015 at 11:59:59 PM PST. These "Events" will be:

- 1) San Diego Comic-Con in San Diego, California
July 9 - 12, 2015
- 2) Rooster Teeth Expo "RTX" in Austin, Texas
August 7 - 9, 2015
- 3) PAX Prime in Seattle, Washington
August 28 - 31, 2015
- 4) Game Stop Show Expo in Las Vegas, Nevada
September 2 - 3, 2015
- 5) Beta Game Access in Los Angeles, California
September 24 – September 30, 2015

By entering and participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Promotion Rules (the "Promotion Rules") and the decisions of WORLDGAMING, 208 Adelaide St. W, Toronto, Ontario, M5H-1W7, which shall be final and binding in all respects.

ELIGIBILITY: Subject to the following restrictions, the Promotion is open to everyone who has reached the age of majority in the jurisdiction in which they reside (19 in AL, 18 in all other U.S. states) ("Age of Majority") before the start of the Promotion. Employees, officers, directors and agents of UBISOFT and WORLDGAMING, and their advertising, media buying and promotional agencies, assigns, parents, affiliated and subsidiary entities and the immediate family (spouse, parent, sibling, child) or members of their same households (whether related or not) of such employees, officers, directors and agents are not eligible to participate in the Promotion. UBISOFT and WORLDGAMING sponsored players are eligible to participate in the Promotion and do not receive any special privileges as they relate to the Promotion. WORLDGAMING shall have the right at any time to require proof of identity, date of birth and/or eligibility to participate in the Promotion. Failure to provide such proof if requested shall result in disqualification. The Promotion is subject to all applicable federal, state, provincial, and

local laws and regulations and is void WHERE PROHIBITED BY LAW.

HOW TO REGISTER: Individuals who choose to enter the Promotion may do so at the Events by registering with their contact information. Individuals (“Entrants”) will then be assigned an individual code/number. All teams must consist of five (5) members, single players will be assigned multiple players to form a team of five (5).

HOW TO PARTICIPATE IN THE PROMOTION: Entrants must play Tom Clancy’s Rainbow Six® Siege (the “Game”) on one of the ten (10) stations available at each live activation during their assigned time. Entrants must compete as a team of five (5) versus a computer generated enemy (“5VE”). The difficulty will be “normal” and mode will be 5VE – Terrohunt Mode. Each round will last a maximum of 15 minutes, but a round may be completed prior to that time when the objective is achieved or the team is eliminated. Scoring will only consist of cumulative team scores. WORLDGAMING reserves the right, in its sole and absolute discretion, to change the game mode, map, objective, or any other aspect of the Game at anytime during the Promotion.

After each round, staff will tally up the team score and enter the information on the leader board. Staff will also collect individual participant numbers to identify with team. The Top 10 teams will be displayed on leader board throughout competition. Participants can join multiple teams to achieve top team scoring.

Any disputes will be resolved by an independent judging organization, whose decision shall be final, conclusive and binding. The judge's decisions shall be made strictly in accordance with these Promotion Rules and any other rules and procedures put in place for the Promotion.

PRIZING: There will be five (5) winners from each of the five (5) live activations, with two (2) teams being chosen from the closed beta, totaling thirty (30) winners for the Siege Day event in Los Angeles, California. Siege Day is scheduled to take place November 23rd, 2015.

- Each winner will receive two round trip airfare tickets for one in economy class from any gateway in the United States to Los Angeles for Siege Day.
- Each winner will receive a two-night hotel stay at a property determined by UBISOFT in Los Angeles for Siege Day.
- Each winner will receive two (2) tickets to the Siege Day event in Los Angeles.

The cash equivalent of the winning prize is estimated at \$1500. No cash equivalency or substitutions of the described prize will be allowed unless Siege Day is permanently cancelled by Ubisoft.

DETERMINING WINNERS: One winning team, comprised of five (5) players from each activation (with two teams being chosen from the closed beta), will earn themselves the opportunity to travel and compete at Siege Day in Los Angeles. There will be six (6) winning teams totaling thirty (30) players. The winning team from each event will be determined by the overall team score and ranked accordingly on the leader board.

WINNER NOTIFICATION: Winners will be notified by email within twenty-four (24) hours of the conclusion of the Promotion. In the event of any dispute concerning the operation of any element of the Promotion, the decision of WORLDGAMING will be final.
